National, regional and state-based organizations involved in the Medicare Rural Hospital Flexibility Program frequently request our Firm’s involvement in educating hospital staff about key issues regarding CAH conversion and assisting with the conversion process.

Since our involvement with the first CAH conversion in Minnesota in 1998, Eide Bailly staff has assisted more than 200 hospitals in 20 states with the CAH financial feasibility analysis, application for participation, and/or survey preparation. Collectively, Eide Bailly staff has worked with more than 20% of the CAHs nationwide on CAH conversion issues.

Critical Access Hospital Designation

Critical Access Hospital status can result in significant reimbursement enhancements from the Medicare program and, if the state adopts Medicare’s reimbursement methodology, significant increases in Medicaid reimbursement. Critical Access Hospital inpatient and outpatient reimbursement is based on cost, with the exception of professional fees, which are based on Resource Based Relative Value Scale (RBRVS). Eide Bailly can help you explore the benefits of CAH status with the following services.

Financial Feasibility Study

We can assist in determining the impact of conversion to CAH status. We will review the past three submitted Medicare Cost Reports to determine the impact on Medicare reimbursement if your facility would have been reimbursed as a CAH facility during those years vs. how your facility was actually reimbursed under Medicare. The review also estimates the impact of the therapy fee schedules and swing bed reimbursement. The study can be adapted to look at only one prior year or at forecasting future years based on anticipated future facility events such as facility expansion, equipment purchases, and adding physicians. We provide a report that includes a recommendation on whether or not the facility should go CAH or if further analysis is necessary.

Submission of the Application

We will prepare and submit all of the necessary paperwork associated with the application for designation as a CAH to the appropriate state agency. This includes assisting you with a rural health network agreement with a tertiary facility, developing the necessary EMS coordination policies, writing the community assessment portion of the application, and compiling all policies needed.

Survey Preparation

The survey preparation consists of a two-day on-site visit to assist you in preparing the required policy manual to meet all the regulations related to CAH status. We will go through the regulations one by one and inform your staff on what needs to be in a policy manual. We will review your current manuals and copy pertinent sections into the CAH manual. If there are components missing, we can provide template policies on-site. Upon completion of the on-site work, the facility will have a manual containing all of the required information. The benefits include survey readiness and time saved by passing the survey the first time.

Review of Interim Rates

We recommend CAH facilities prepare a mini-cost report at least once or twice a year to verify the interim payment rates received from Medicare. Depending on the accuracy of variation in expenses, patient day activity and Medicare utilization, there could be major swings in Medicare reimbursement that result in either a major payable or receivable on the cost report. We can help complete the interim cost reports and recommend adjustments to the interim payment rates.

CAH Reimbursement Analysis

Cost reimbursement rules create opportunities for hospitals licensed as CAH facilities to review current operations and examine how the Medicare cost report is completed. Opportunities may exist that could impact the amount of reimbursement received from the Medicare program. We conduct a thorough review of your most recently filed Medicare cost report, complete an extensive tour of the facility and work with your accounting personnel regarding recording of expenses in the general ledger. We complete other analyses to determine whether you are receiving the appropriate reimbursement from the Medicare program.

Assurance and Tax Services

For a CAH facility, the chargemaster and cost report are two of the most vital components for proper cost reimbursement from Medicare. We review each chargemaster section to ensure proper code usage and adherence to pricing and compliance issues. We check for proper revenue and expense matching for the Medicare cost report and educate facility staff on the impact the chargemaster and the cost report have on reimbursement.
